Rolling Green PTO paid for Dan Dance C'motion Revolution to work with students November $1^{\rm st}$ - $4^{\rm th}$ - C'motion is a music-driven exergaming experience that keeps the mind and body in action. Jensen students will experience C'motion Revolution as well paid for by "Shop Your School" Merle Hay Mall donations.
