I. Call to Order and Roll Call

President Ryan Judas called the board meeting to order at 7:00 P.M. Upon roll call, the following members were present: Directors Jeff Farrell, Vice President Adam Obrecht, Shawn St. John, Mark Wierson, and President Ryan Judas. Directors Cate Newberg and Kyle Kruidenier were absent.

II. Approval of Agenda

Director Wierson moved, and Director St. John seconded the motion to approve the agenda as posted. Motion carried with all ayes 5-0.

III. Student Senate Report

Seventh grader Enrique Idehen reported that the Middle School would be sending five boxes of Love Packages to US Troops containing beef jerky, candy, and nuts. Valentine's Day fundraising will be used for a student party in May. Senior Grant Wierson updated the Board of Directors about a possible senior lounge at the High School and that hundreds of dollars have been raised this year for the Urbandale Food Pantry.

IV. Meet with your Legislature

Invited guest speakers Senator Brad Zaun and Representative Scott Raecker updated the Board of Directors about school funding and other Iowa Legislature topics related to schools and education.

V. Communication from the Public

John Hollebrands of 4217 86th Street addressed the Board on the topic of the January 23rd IT Consultant's Presentation. Carla Johnson of 3405 Melanie Drive spoke on the topic of student behavior at school dances.

VI. Good News

Congratulations to Urbandale Girls Basketball Coach Mark Tiby on his 400th Career Victory on Tuesday, night (January 24th). The J-Hawks beat Fort Dodge 64-30. This is Tiby's 35th season overall and 20th at Urbandale. Valerius Elementary School students donated over 100 winter items to the Central Iowa Shelter. Webster Student Council raised \$186.26 for the Pennies for Patients (organization through the Leukemia and Lymphoma Society of Iowa) as part of their focus on Character and the Pillar of Caring. UMS will be taking 50 students to the Iowa's Healthiest State Initiative event featuring First Lady, Michelle Obama, being held at Wells Fargo Arena on Thursday, February 9th. In Grace Chance's honor, staff and students at UMS helped raise more than \$2,436 in the Math-a-thon. Jacqueline Eppard's 6th grade class raised \$1,240 of that total. Urbandale senior, Gabriel Moreno, captured his 3rd CIML Championship in four years, winning the 145lb weight class at Friday's Meet at Southeast Polk. Moreno and the J-Hawks, who placed 11th overall, will compete in the District Meet at Dowling on Saturday, February 11, 2012. Little J-Hawks Wrestling Team sent 12 kids to District and 5 to State Competitions.

Motion passed with all ayes 5-0.

C. Authorization to Pay Bills

Shelly Clifford, Director of Business Services, requested Board authorization to pay bills as submitted. Director Farrell moved, and Director St. John seconded the motion to pay the bills as submitted, totaling \$811,134.53. Motion passed with all ayes 5-0.

IX. Report of the President

President Ryan Judas updated the Board of Directors about beginning the fiscal year 2014 Certified Budget process in December of 2012 to allow for more discussion and greater

transparency for the public. Shelly Clifford will present an overview of the Certified Budgeting process at the February 20, 2012 meeting.

X. Discussion of Other Matters

Superintendent Dr. Stilwell communicated to Directors that the Community Education program currently outsourced through the City of Urbandale will be discontinued due to financial constraints, and that administration of that program has been assigned to District staff.

At 8:40 P.M., President Judas announced a five minute recess.

XI. Closed Session

A. Mid-Term Evaluation of Superintendent

In open session at 8:45 P.M., Director Farrell moved, and Vice President Obrecht seconded the motion to enter into closed session for the purpose of the Superintendent's mid-year review, pursuant to Section 21.5(l)(i) of the Code of Iowa, and as requested by the individual, to evaluate the professional competency of the individual whose appointment, hiring, performance, or discharge is being considered to prevent needless and irreparable injury to that individual's reputation. Upon roll call vote, motion passed with all ayes 5-0.

The Board of Directors returned to open session at 9:39 P.M.

C. Superintendent's Contract

Vice President Obrecht moved, and Director St. John seconded the motion to approve a three-year employment contract for Superintendent, Dr. Doug Stilwell, at current compensation level, with option to change compensation in years one, two and three.

Director St. John moved, and Vice President Obrecht seconded the motion to adjourn the meeting at 9:40 P.M. Motion passed with all ayes 5-0.
