Approval of Agenda

Report of the Superintendent of Schools

A. Building Maintenance Updates

Dr. Doug Stilwell, Superintendent, and John Lees, Supervisor of Maintenance and Construction, updated Board members on summer construction projects. Structural repairs at Jensen Elementary are nearly complete; Webster Elementary parking lot is finished and play pad concrete poured. Next step for the contractor is installation of Webster and Jensen play pad tiles. A new sidewalk was installed near the baseball field. Gym lighting projects are

planned at the high school. New camera systems have been installed in some buildings, allowing other features such as exterior lockdowns from remote access. Baseball and softball bleachers have been removed and the new bleacher installations will be underway in September.

B. Approval of Urbandale High School's Interim Administrators' Salaries for the 2013-14 Fiscal Year

Dr. Doug Stilwell, Superintendent, presented the proposed salaries for the Urbandale High School Interim Administrators for the 2013-14 fiscal year only. Brian Coppess will serve as interim High School Principal; and Tim Carver will serve as interim Associate High School Principal. Director Wierson moved, and Director St. John seconded the motion to approve the interim positions and salaries as submitted. Motion passed with all ayes 4-0.

C. Accept the Financial Report

Shelly Clifford, Chief Financial Officer, requested acceptances of the financial report through July 2013. Director St. John moved, and Director Kruidenier seconded the motion to approve the financial report as submitted. Motion passed with all ayes 4-0.

D. Authorization to Pay Bills

Shelly Clifford, Chief Financial Officer, requested approval to pay the bills as submitted, totaling \$1,259,112.31 and \$512,118.94. Director Kruidenier moved, and Director St. John seconded the motion to approve the payment of bills as submitted. Motion passed with all ayes 4-0.

Adam reported than there are three candidates for the three open school board seats. He reminded patrons to vote on September 10, to ensure there are adequate votes to elect the candidates who have been nominated to serve.
